IN 2019, YAMBA MALAWI IMPACTED THE LIVES OF OVER 34,000 CHILDREN AND THEIR COMMUNITIES BY EMPOWERING SIX CBO PARTNERS TO IMPROVE THE QUALITY AND QUANTITY OF THE SAFETY NET SERVICES THEY PROVIDE TO VULNERABLE CHILDREN, AND BY LAUNCHED 650 HOUSEHOLDS ON A PATHWAY OUT OF EXTREME POVERTY. AT THE COMMUNITY LEVEL, THIS RESULTED IN NUTRITIOUS SCHOOL MEALS FOR THOUSANDS OF CHILDREN, 84 SECONDARY SCHOOL SCHOLARSHIPS, SCHOOL MATERIALS LIKE BOOKS AND UNIFORMS FOR OVER 1,000 CHILDREN, BLANKETS AND CLOTHES TO 1,200 CHILDREN, AND RENOVATION OF FIVE CBCCS, INCLUDING CONSTRUCTION OF A COMMUNITY LIBRARIES AND PURCHASES OF BOOKS AND TOYS FOR YOUNG CHILDREN.
